

District heating delivery agreement – Gas conversion (property where gas company is not entitled to compensation *)

An agreement has been reached between the owner(s) of the property below and Billund Varmeværk a.m.b.a. to connect district heating to the property located:

- Dismantling and disposal of the existing gas installation
- Excavation and laying up to 20 meters of district heating supply line. Additional length will be invoiced pr. meter according to the tariff sheet
- Supply line finished with main taps just inside the outer wall
- Re-establishment of excavation
- Assembly and connection of the unit including the circulation pump excluding the hot water circulation pump
- Billund Varmeværk inspects and approves the installation

By signing this agreement, the owner of the property confirms that the

- Articles of association (Vedtægter)
- General- and Technical provisions for district heating delivery (Almindelige- og Tekniske bestemmelser for fjernvarmelevering)
- Tariff sheet (Takstblad)

Important regarding the gas disconnection !!

Owner(s) of the property must themselves apply for a grant to disconnect the gas supply from Evida.

Please be aware that the subsidy pool for disconnection of gas may be closed when the amount set aside by the Danish parliament has been used up. If the pool is used up, the owner(s) must pay for the disconnection themselves.

Important regarding BBR information!!

*** Information regarding gas company compensation!!**

The gas company is entitled to compensation for disconnection of the gas network on some newer land sections. The compensation is to cover the gas company's expenses for distribution networks that have not been fully depreciated. No compensation shall be paid for this property.
